The undersigned is directed to refer to the above subject and please to brought to the notice of the Institutions/Students and other various stakeholders that ragging is criminal offence and Pharmacy Council of India has framed regulations, on curbing the menace of ragging in Pharmacy Colleges in order to prohibit, prevent and eliminate the scourge of ragging. The Regulations are called (**Pharmacy Council of India Regulations on Curbing the Menace of Ragging in Pharmacy Colleges, 2012**). The Regulations under reference have been notified in the Gazette of India No.34, Part-III, Section 4, dated August 25 – August 31, 2012. These Regulations are available on the PCI website i.e. “[www.pci.nic.in](http://www.pci.nic.in)”.

The said regulations are mandatory binding in all characters and all the institutions/colleges are advised to implement the said regulations in letter and spirit so that, the menace of ragging in Pharmacy Colleges can be curbed.
