Subject: Reservation for Economically Weaker Sections (EWSs) for admission in Central Educational Institutions – regarding.

The undersigned is directed to forward herewith a copy of self explanatory O.M. dated 17.01.2019 of the Ministry of Human Resource Development for implementation of reservation for Economically Weaker Sections (EWSs) in admission to educational institutions from academic year 2019-20 onwards for the admission to educational institutions from academic year 2019-20 onwards for the students/candidates who are not covered under the existing schemes of students/candidates who are not covered under the Constitution (One reservation of SC/ST/OBC and as per the mandate of the Guidelines are as Hundred and Third Amendment) Act, 2019. The highlights of the guidelines are as follows:

- a) The 8 Institutions of excellence, research institutions and institutions of national and strategic importance as specified in the Schedule to The Central Educational Institutions (Reservation in Admission) Act, 2006 and minority educational institutions referred to in Article 30(1) of the Constitution are exempted from the operation of this Amendment Act, 2019. Constitution are exempted from the operation of this Amendment Act, 2019 and Medical Science, Shillong (NEIGRIHMS) is one of the 8 Institutions exempted by the Act, 2006,

 - c) The applicability of this Amendment Act, 2019 for increase of the annual permitted strength need to be implemented from the academic year following the commencement of the Amendment Act but in case the annual permitted the commencement of the Amendment for reasons of financial, physical or strength cannot be implemented for reasons of financial, physical or academic limitation, such increase can be implemented over a period of two

years beginning with the academic session 2019-20, after the representation by the Central Education Institution to the appropriate authority and subject to its satisfaction on the grounds as stated above. At any stage of implementation of EWS reservation, the number and percentage of reservation provided for SC/ST/OBC categories shall not be reduced.

- d) The scheme for implementing the reservation for the EWS shall be displayed on the website of the Institution as soon as possible, but no later than 31.03.2019.
- 2. The Indian Nursing Council and the Pharmacy Council of India have been asked to take all necessary measures including enabling amendments in the Regulations, if required, to facilitate implementation of the provision of the Constitution (Amendment) Act 2019 with immediate effect.
- 3. All concerned Divisions dealing with Nursing/Pharmacy Educational Institutions are requested to take appropriate action for implementing the provisions of the Amendment Act in the Institutes/Bodies etc. under their administrative control.
- 4. This issues with the approval of Hon'ble Minister for Health & Family Welfare.

OFFICE MEMORANDUM

Subject: Reservation for Economically Weaker Sections (EWSs) for admission in Central Educational Institutions.

In accordance with the provisions of the Constitution (One Hundred and Third Amendment) Act 2019, and the reference of Ministry of Social Justice and Empowerment vide OM No. 20013/01/2018-BC-II dated 17th January 2019, enabling provision of reservation for the Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes, it has been decided to provide reservation in admission to educational institutions subject to a maximum of ten per cent of the total seats in each category. This would not apply to the minority educational institutions referred to in clause (1) of Article 30 of the Constitution of India.

2. The provision of reservations to the Economically Weaker Sections shall be in accordance with the directions contained in the OM No. 20013/01/2018-BC-II dated 17th January 2019 of the Ministry of Social Justice & Empowerment and shall be subject to the following:

a) The reservations shall be provided to EWSs for admission in Central Educational Institutions, (as defined in clause (d) of section (2) of The Central Educational Institutions (Reservation in Admission) Act, 2006) from the academic year 2019-

b) The above reservation would not be applicable to the 8 institutions of excellence, research institutions, institutions of national & strategic importance as specified in the Schedule to The Central Educational Institutions (Reservation in Admission) Act, 2006, as amended from time to time, and appended to this OM, and to the minority educational institutions referred to in clause (1) of article 30 of the Constitution.

c) Every Central Educational Institution shall, with the prior approval of the appropriate authority (as defined in clause (c) of section 2 of The Central Educational Institutions (Reservation in Admission) Act, 2006), increase the number of seats over and above its annual permitted strength in each branch of
