
With reference to the subject cited above, I am directed to inform that subject cited issue was considered by Executive Committee the Pharmacy Council of India in its meeting held in Nov, 2013, which decided to again write to all the institutions to -

- a) strictly follow the "Pharmacy Council of India Regulations on Curbing the Menace of Ragging in Pharmacy Colleges, 2012." The same are available on Council's website www.pci.in .
- b) be proactive in the matter.
- c) ensure that the Anti-Ragging Committee constituted by the institutions promptly addresses the grievances of the students including the cases relating to harassment of female students.
- d) clarify that in case of any lapse, the Management, the Principal and the concerned Teaching Staff will be responsible for it.

You are requested to strictly comply with the provisions of the Pharmacy Council of India Anti-Ragging Regulations.

A copy of the Ministry of Human Resource Development D.O. letter 16-8/2013-U.5 dt. 18.11.2013 regarding filing of the undertaking on anti-ragging by the students and parents online is enclosed herewith (as **Appendix-I**) for information and necessary action.

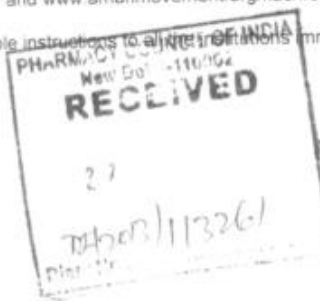
Dear Madam/Sir,
