

PUBLIC NOTICE

1. The list of the institutions whose applications have been received by the Pharmacy Council of India (PCI) within the prescribed period i.e. between 1st August, 2017 to 31st August, 2017 for consideration of approval of new pharmacy college(s) / course(s) for the academic session 2018-2019 has been uploaded on the Council's website www.pci.nic.in under the heading "Announcements".
2. An inspection of said institutions will be conducted by the PCI u/s 16 of the Pharmacy Act, 1948 in due course of time. In view of it, institutions are advised to -
 - a) create infrastructural facilities as prescribed under the concerned Education Regulations for the applied pharmacy course(s) as posted on the Council's website www.pci.nic.in
 - b) appoint Principal and obtain consent of joining in respect of other teaching faculty as per the qualification and experience prescribed under the "Minimum Qualification for Teachers in Pharmacy Institutions Regulations, 2014" for the 1st year of the proposed course of study.
3. To submit the following documents (English or Hindi version only) for consideration of approval under the Pharmacy Act -
 - a) consent of affiliation of the Examining Authority for starting of course(s) for the session applied for by the institution. (applicable to institutions applying for any of the following courses -
 - D.Pharm
 - B.Pharm (Practice)
 - B.Pharm
 - M.Pharm
 - Pharm.D
 - b) NOC / approval of the State Govt. for starting of B.Pharm course for the session applied for by the institution. (applicable to institutions applying for B.Pharm course).

4. Where the documents i.e. consent of affiliation of Examining Authority and NOC/approval of the State Govt. to be submitted by the institution are not submitted alongwith the Standard Inspection Form (SIF) to PCI, the institution shall submit the same as soon as possible but without fail before making admissions. Such institution shall submit duly notarized affidavit on court paper as per following formats –
 - a) Format of affidavit to be submitted by the institutions applying for D.Pharm / Pharm.D./ M.Pharm / B.Pharm (Practice) course. **(Appendix-I)**
 - b) Format of affidavit to be submitted by the institutions applying for B.Pharm course. **(Appendix-II)**
5. In view of above, the institutions are advised to hand over the duly signed and attested affidavit, in original, to the visiting inspectors at the time of inspection for submission to PCI alongwith the inspection report.
