Sub.: Measures taken by the National Law University, Delhi to prevent and deal with the incidence of ragging.

Sub: Reg. Taking all measures and effective and efficient steps to prevent and deal with any ragging in the institutons of higher learning.

Dear Sir.

Please refer to your letter No. DHE6(6)/2013-14/Misc./5215-17 dt. 06.01.2014 and its subsequent reminder No. DHE6(6)/2013-14/Misc./3726 dt. 03.09.14 on the above subject.

In this connection, I am to inform your that this University has taken the following steps to prevent ragging:

1. In the Orientation of 1st year students held on August 1 and 2, 2014 the Vice Chancellor personally interviewed each fresher and sensitized them. Similarly when the orientation of 2nd, 3rd, 4th and 5th year was held, it was sternly brought to the notice of the students that if any case of ragging against them was noticed, severe action would be taken against them as per rules.

- The Anti Ragging squad has been constituted (Copy of the notification enclosed). The members of the Committee are watchful and vigilant. The members of the Committee take rounds of the Hostels to check if there is any incident of ragging.
- 3. The University had installed CCTV in the Hostel, Library and Academic blocks.
- 4. Anti Ragging posters have been displayed in the Hostels and Academic blocks.
- The University is also organising Semiar / Workshop from time to time to sensitise the sudents.
- At the start of Academic Sessions, the fauclty members also empowered to stay in the hostels at night for a period of 15-20 days to curb any possibilities of ragging.

It is informed that no case of ragging has come to the notice since its inception i.e 2008 due to alertness of the Faculty members and Staff.
