Additional Secretary, Ministry of Health & Family Welfare, took a Meeting on 18.4.2017 in coordination with FSSAI. Concerns were expressed regarding Junk Food, Unbygienic Food, Adulterated Food, Substandard Food, Non-labelled Food, Non-wholesome Food, Non-quality Food, Non-Standardized Food, Non-certified Food, Unapproved Food, Non-nutritious Food, Food and Snacks and Beverages with too much of (more than the normal standard required) Salt, Sugar and Fat contents leading to obesity and other problems, Hydrogenated Food, Trans-fat Food, BP and other life-style diseases/problems. Concerns were expressed in the context of Canteens/Food Stalls/Attitude towards fast food as distinct from slow food/Habit of taking food and snacks with unauthorized and unapproved vendors/stalls/Dhabas/Outlets/Road stalls / Footpath stalls. Concerns were also expressed in the wrong processes in processed food. Concerns were also expressed on diet imbalance and unhealthy food. Need for behavioural change and attitudinal change towards fast-food and other ill-advised food was also suggested.

It is also understood that the Ministry of Health & Family Welfare requested Department of School Education and Literacy to share/publicize books on healthy children healthy India/ healthy food/healthy living, The books are with Department of School and Literacy. All concerned are requested to note for further action please.
