This is in continuation to Council's circular dt.11.07.2022.In this connection, it is clarified that -

1. The inspectors, any time will come your college for inspection of Experimental Pharmacology Series Software & Microsoft Software Application and OS. The inspection process and submit on the time the inspection report.
2. According to New Education Policy (NEP), Experimental Pharmacology Series Software & Microsoft Software Application & OS License is mandatory. PCI gives order to all of existing Institute that software application and OS Purchase all software.
3. You should remember, that you have to Purchase all software License to Microsoft Authorized Compliance Partner. You have to submit Software License Invoice & Microsoft Authorized Partner certificate to same email id.
4. Microsoft Software License should be Minimum Quantity 15 (MS Office = 15 & OS = 15) and More than. Microsoft Partner Authorization Letter should be on Microsoft Letterhead. You have to email all Software Invoice Copy & Microsoft Partner Authorization letter on given email id , all document submit within 45 Days. It's a Mandatory.
5. Please note that Council's Circular dt.11.07.2022 is for existing institute of PCI. An inspector reaches an institution for inspection of Microsoft License, and do not find out Microsoft License Invoice and Microsoft Authorized Partner Certificate. Institution cannot refuse software License based on the said circular. All these instructions are through NIC Hyderabad.
