- 1. Another opportunity for submission of application has been granted from 4th August, 2022 to 10th August, 2022
- 2. Please note that it is the last opportunity and there will not be any further extension of last date beyond 10th August, 2022.
- 3. It is further informed that
 - a) the institutions which have already applied to PCI between 3rd to 15th July, 2022 can submit -
 - SIF
 - PERC
 - Statutory documents (if not already submitted)
 - b) the institutions which did not apply between 3rd to 15th July, 2022 can now apply with following documents
 - i) registration fee of Rs.10,000/-.
 - ii) Statutory documents.
 - iii) SIF.
 - iv) PERC.

- c) The institutions which had already registered on PCI portal which was opened earlier as per Hon'ble High Court's directions on moratorium cases but their applications were not processed as the moratorium issue was sub-judice can also apply. For such cases, it was decided that such institutions can also apply and submit the following documents
 - i) SIF.
 - ii) Statutory documents.
 - iii) PERC.
- 4. Further, it is clarified that the Security Deposit will be given by the institution only if the approval is granted.
- 5. All the institutions are again advised not to wait for the last date as crowding may slow down the server, hence application be submitted at the earliest within the stipulated date.
