8.1 The latest information on record including order dt.2.6.2020 passed by Hon'ble High Court of Telangana at Hyderabad in Writ Petition No.7401 of 2020 was placed and considered alongwith the following facts –

- a) Judgement dt.5.3.2020 passed by Hon'ble Supreme Court of India in Transfer Petitions (Civil) Nos. 87-101 of 2014.
- b) Council's mail dt.26.3.2020 seeking information in pursuance of Hon'ble Supreme Court judgement dt.5.3.2020.
- c) reply dt.24.4.2020 received from the institution.

#### 8.2 It was noted that -

- a) Hon'ble High Court vide above cited order has directed to dispose of the representation, dated 24.04.2020 duly taking into consideration the orders of the Hon'ble Supreme Court, dated 5.3.2020, the Inspection Reports and the earlier intake granted by AICTE within a period of two weeks from the date of receipt of a copy of this order.
- b) the PCI did not receive the Writ Petition.
- 8.3 The matter was threadbarely discussed and it was noted that
  - a) the Hon'ble Supreme Court of India in its judgment dt.5.3.2020 has held that in the field of Pharmacy Education and more particularly so far as the recognition of degrees and diplomas of Pharmacy Education is concerned, the Pharmacy Act, 1948 shall prevail. The norms and regulations set by the PCI and other specified authorities under the Pharmacy Act would have to be followed by the concerned institutions imparting education for degrees and diplomas in Pharmacy, including the norms and regulations with respect to increase and/or decrease in intake capacity of the students and the decisions of the PCI shall only be followed by the institutions imparting degrees and diplomas in Pharmacy".
  - b) the said judgment further directed the concerned institutions who increased their intake capacity as approved by AICTE and their increase in intake capacity was not approved by PCI, shall apply afresh for increase in intake capacity and/or evening shift for the next academic year within a period of four weeks from the date of judgment and their cases for increase in intake capacity and/or applications for recognition and/or applications for approval of the course or evening shift shall be considered by the PCI in accordance with the Pharmacy Act, 1948 and rules and regulations framed therein and the norms prescribed by the PCI.
  - c) pursuant to above judgment, the PCI vide mail dt.26.3.2020 sought information from the institution.
  - d) the institution vide letter dt.24.4.2020 submitted the reply.

- 8.4 In view of the judgment dt.5.3.2020 passed by Hon'ble Supreme Court, statutory provisions of various Education Regulations framed by the PCI u/s 10 of the Pharmacy Act, 1948 and order dt.2.6.2020 passed by Hon'ble High Court of Telangana (Hyderabad) it was noted and decided as under
  - (A) With regard to the institution's request for D.Pharm and Pharm.D course, it was noted that
    - a) for 2019-2020 academic session, it is mandatory to institutions to apply online on PCI portal.
    - b) the PCI Portal was opened from 15.11.2019 to 27.12.2019 and 7.1.2020 to 13.1.2020 for submitting the application in prescribed format called Standard Inspection Form(SIF) alongwith prescribed fee to enable the Council to process the application for approval under the Pharmacy Act, 1948.
    - c) the institution did not apply online and failed to submit application for D.Pharm and Pharm.D course alongwith prescribed fee.

In view of above, it was decided that the institution may apply online for these courses on PCI portal during next academic session.

## (B) Regarding B.Pharm Course

- a) It was noted that
  - i) with regard to intake in B.Pharm course, Regulation-5. of "The Bachelor of Pharmacy (B.Pharm) Course Regulations, 2014" mandates that number of admissions in B.Pharm course shall be as prescribed by the PCI from time to time.
  - ii) the admissions to B.Pharm Course are restricted to 100 as prescribed under the Scheme framed under Regulation 9(1) of the said Regulations.
  - iii) Hon'ble Supreme Court in its judgement dt 05.03.2020 has upheld that norms, standards and regulations with regard to intake capacity of students and decision of PCI shall only be followed.
- b) In view of above it was decided to reiterate the decision of 109 CC (April, 2020) as under:

To grant approval to B.Pharm course upto 2022-2023 academic session for 100 admissions.

- 8.5 With regard to the already admitted students pursuant to interim order passed by Hon'ble High Court, it was decided to process the matter as per the judgment dated 5/3/2020 passed by Hon'ble Supreme Court of India.
- 8.6 In the light of time bound court order, it was further decided to take action in anticipation of approval of the minutes from the Hon'ble President.
