The All India Survey on Higher Education (AISHE) for the year 2019-20 has been commenced with effect from 1st January, 2020. Initially, all the institutions of higher education in the Country were requested to upload the data on AISHE portal (<u>aishe.gov.in</u>) by 31st March, 2020, which was the closing date of the survey but now it has been extended up to 31st May, 2020.

2. Almost four months has been elapsed but the progress of data uploadation on AISHE portal is abysmally low. MHRD is targeting 100% data uploadation by all the institutions of Higher Education in the country.
