#### ORDER

has filed this application for extension of the cut off date for grant of affiliation till 15.09.2021 in respect of all technical institutions including colleges of Pharmacy, Engineering and Architecture for the present Academic Session 2021-2022. Mr. Amitesh Kumar, learned counsel appearing for the applicant, referred to two orders passed by this Court extending the last date for approval by the AICTE and Pharmacy Council of India for this Academic Year. The University had to wait for the

approvals granted by the Regulatory Bodies before considering the applications filed for affiliation of the Colleges. He referred to Clause 6.01 of the Gautam Budh Technical University, Lucknow First Regulation, 2010, according to which, grant of approval by AICTE, Pharmacy Council of India and Council of Architecture is a sine qua non for applying for affiliation. He also relied upon an e-mail sent by the AICTE on 29.07.2021 by which the final list of colleges to which approval was granted was notified. There are 865 technical institutions whose applications for affiliation have been pending before the University and unless the cut off date is extended, the institutions and the students would suffer.

Natraj, learned K.M. have heard Mr. for AICTE, Mr. Additional Solicitor General Hossain, learned counsel appearing for Pharmacy Council of India and Ms. Hetu Arora Sethi, learned counsel appearing for Council of Architecture. It was submitted by the learned counsel appearing for the Regulatory Bodies that the affiliation being granted on the basis of final approvals given by the Regulatory Bodies can be done without disturbing the schedule that was given in the revised calendars for admission for the Academic Session 2021-2022. As long as no new application is filed which requires to be considered by the Regulatory Bodies, they do not have any objection for an extension of the cut off date for grant of affiliation to the Technical

Institutes which are affiliated to the University.

As we are informed that orders for grant of affiliation to the Institutions are ready, we grant three days' time from today for the orders to be passed by the University. We make it clear that the orders for affiliation are passed on the basis of final approval granted by the Regulatory Bodies.

The AICTE, Pharmacy Council of India and Council of Architecture shall inform all the technical Universities about this order through their websites and that any pending applications for affiliation on the basis of final approval granted by them can be disposed of within a period of three days from today.

Miscellaneous Application as well as I.A.(s) stands disposed of.
