1. The Pharmacy Council of India (PCI) invites applications for starting of new pharmacy institutions [wherever applicable in the light of PCI moratorium for 2020-2021 academic session (for moratorium details, please see PCI website)] / additional course(s), increase in intake capacity and extension of approval from 2020-2021 academic session through the PCI web portal www.pci.nic.in. A user manual for filling up the application is available on the Council's website.
2. The portal shall open from 15.11.2019 to 15.12.2019 and the institutions are required to submit the application with the prescribed documents within the stipulated time period only.
3. A provision under the heading "SERVICES" has been provided for pharmacy institutions intending to make proposals for the change in the name, address of the institution, change of examining authority, change of hospital (in case of Pharm.D institutions), closure of any course or institution etc. The procedure for the same is as under –
 - a) Please login.
 - b) On the Left Hand Side (LHS) of the Menu option there is a module for "Services" at the bottom.
 - c) Click in to find the various services offered and submit the application accordingly with prescribed fee.
 - d) Please note that fee will not be refunded in case application is incomplete / wrong document is uploaded.
4. Please note that -
 - a) Only online application will be accepted. No offline applications shall be entertained by the PCI and will be summarily rejected.
 - b) even existing institutions which are already approved for future sessions have to submit the SIF by paying necessary fees.
 - c) for institutions which have already paid the affiliation fee, due credit will be given for prospective session/s.
